Subject: Consolidated Scrutinizer's Report on Postal Ballot and E-voting conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 of Companies (Management and Administration) Amendment Rules, 2015 in respect of passing the Special resolution contained in the Notice dated March 14, 2016 through Postal Ballot.

I, L.N. Joshi, Practicing Company Secretary, Indore being appointed as scrutinizer by the Board of Directors of Anik Industries Limited in their Boar Meeting held on 14th March, 2016 pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of SEBI (Listing Obligation and Disclosure Requirements) Regulations 2015 to conduct the Electronic Voting Process and Postal Ballot in respect of the special resolution proposed through Postal Ballot and E voting.

I submit my report as under:

1. The Company had dispatched Notice of Postal Ballot dated March 14, 2016 to the Shareholders along with postal ballot form, self addressed postage prepaid business reply envelope on 24th March, 2016 to shareholders whose name appeared on register of members as on 18th March, 2016 being the cut off date and also published the Advertisement in news papers i.e. Free Press Journal, Mumbai in English language and in Navshakti, Mumbai in Regional language pursuant to Rule 22(3) of the Companies (Management and Administration) Amendment Rules, 2015.

- 2. The Voting Commenced on Friday, March 25, 2016 (10.00 A.M.) and ended Saturday April 23, 2016 (05.00 P.M.) for physical ballots and as well as for evoting.
- 3. The Shareholders of the Company holding shares as on the cut off date of March 18, 2016 were entitled to vote on the special resolution as contained in the Notice of Postal ballot.
- 4. The e-voting facility was provided by Central Depository Services (India) Limited (CDSL). The votes were unblocked on April 23, 2016 around 07.45 P.M. in the presence of two witnesses, viz. Mr. Sishir Dubey and Mr. Bhushan Tambe, who are not in the employment of the Company. They have signed below in confirmation of votes being unblocked in their presence:

- 5. All postal ballot forms received up to 5.00 P.M. on $23^{\rm rd}$ April, 2016, being the last date fixed by the Company for receipt of the postal ballot forms were considered for my scrutiny. No envelope containing postal ballot forms were received after 5.00 P.M. on $23^{\rm rd}$ April, 2016.
- 6. Total envelopes containing 284 postal ballot forms returned undelivered up to 23rd April, 2016.
- 7. I have scrutinized and reviewed the e-voting and votes tendered therein based on the download from the CDSL e-voting system.
- 8. With respect to physical ballot, the ballot papers received were reconciled with the records maintained by the Registrar and Share Transfer Agent. The signature verification in respect of physical postal ballot forms have been verified by officer of Registrar and Transfer Agent of the Company i.e Sarthak Global Limited.
- 9. I did not find any defaced or mutilated postal ballot form.
- 10. The Shareholders have casted their vote either by electronic or physical mode. There was no shareholder who opted for both the facilities.

I now submit my consolidated report as under on the result of the E-voting and physical ballots papers in respect of the special resolution contained in the Notice of Postal Ballot.
